ORDINANCE NO. SP- 2927 S- 2020

AN ORDINANCE AMENDING ORDINANCE NO. SP-2922, S-2020, OTHERWISE KNOWN AS THE "SUPPLEMENTAL BUDGET NUMBER 3, GENERAL FUND FOR FISCAL YEAR 2020", PARTICULARLY THE ITEM ON MEDICAL, DENTAL AND LABORATORY SUPPLIES EXPENSES AMOUNTING TO FIFTY MILLION PESOS (PHP50,000,000.00).

WHEREAS, on 27 April 2020, Ordinance No. SP-2922, Series of 2020 was approved by the City Council providing for Supplemental Budget No. 3, in the amount of One Billion Four Hundred Thirty Million Pesos (Php1,430,000,000.00) to fund various Maintenance and Other Operating Expenses of the City Government to further respond to Coronavirus Disease 2019 (COVID-19) pandemic;

WHEREAS, the budget items for medical, dental and laboratory supplies expenses in the amount of Fifty Million (Php50,000,000.00) was approved and incorporated in the said Supplemental Budget No. 3;

WHEREAS, there is a need to amend such item on the appropriation ordinance to procure the needed medical equipment necessary to effectively address the effects of COVID-19 in Quezon City.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Ordinance No. SP-2922, S-2020, otherwise known as the "Supplemental Budget No. 3, General Fund for Fiscal Year 2020" particularly the items on medical, dental and laboratory supplies expenses in the amount of Fifty Million Pesos (Php50,000,000.00) thereof, is hereby amended to read as follows:

Maintenance and Other Operating Expenses

| Medical Supplies Expenses | Php18,281,060.00 |
|-------------------------------------|------------------|
| Other Property, Plant and Equipment | Php413,960.00 |
| Medical Equipment | Php31,304,978.00 |

Provided, that the other items and corresponding appropriation contained in Ordinance No. SP-2922, S-2020 shall remain in full force and effective on its enactment.

SECTION 2. SEPARABILITY CLAUSE - If for any reason, any section or provision of this Ordinance is declared to be unconstitutional or invalid, all other provisions hereof which are not affected thereby shall continue to be in full force and effect.
