*WHEREAS, there is a need to find ways and establish a system to eliminate long queues and simplify the procedures of securing health clearance from Quezon City Health Department;*

*WHEREAS, the long queues can be eliminated and the application for securing health clearance can be simplified through an online application and scheduling system;*

WHEREAS, applicants can fill up forms online and go to the Quezon City Health Department on the scheduled date they have chosen which is a fast and a convenient way in securing health clearance;

WHEREAS, President Rodrigo R. Duterte has instructed government agencies and local government units to create a system wherein people need not endure the bureaucratic application for government papers.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY  
IN REGULAR SESSION ASSEMBLED:

SECTION 1. The Quezon City Health Department (QCHD) is hereby mandated to adopt an online application, enrollment, renewal and document verification system in the issuance of health clearance in Quezon City.

SECTION 2. The QCHD, through the assistance of the Quezon City Information Technology Development Department (QC ITDD), shall develop a systems proposal, or request and review systems proposal from any IT company, for the online application, enrollment and documents verification system in the issuance of health clearance in Quezon City before its submission to the City Mayor for final approval and implementation.

SECTION 3. The fund for the said system including the personnel complement shall be included in the budget proposal of the Quezon City Health Department for Fiscal Year 2021.

SECTION 4. If for any reason any portion of this Ordinance is declared to be unconstitutional or invalid, all other provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 5. All ordinances, resolutions, memoranda, orders and other issuances which are inconsistent with this Ordinance are hereby repealed or modified accordingly.
