WHEREAS, on November 9, 2020, Ordinance No. SP-2979, S-2020, was enacted granting tax amnesty to real property owners from the payment of interest, for delinquent real property taxes;

WHEREAS, under Section 4 thereof, the availment period for the tax amnesty is until March 31, 2021;

WHEREAS, on March 29, 2021, the National Capital Region and several nearby provinces, were placed under Enhanced Community Quarantine and pursuant to the amendment of the omnibus guidelines issued by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-MEID), under Resolution 106-B, mandates the adoption of reduced on-site capacity, with LGU's to implement and adopt a skeleton workforce and alternative work arrangement to make the LGU's still fully operational;

WHEREAS, Enhanced Community Quarantine restricts the movement of people within its coverage area;

WHEREAS, to fully implement the policy of the Quezon City Government and to ease the impact of economic adversities on its constituents while enabling the collection of taxes, there is an urgent need to extend the availment period of the grant of tax amnesty.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN SPECIAL SESSION ASSEMBLED:

SECTION 1. AMENDMENT TO SECTION 4, ORDINANCE NO. SP-2979, S-2020. - Section 4 of Ordinance No. SP-2979, S-2020 is hereby amended extending the availment period of the tax amnesty from March 31, 2021 to April 20, 2021.


