AN ORDINANCE RETITLING THE NOMENCLATURE OF MECHANIC POSITIONS UNDER THE BUILDINGS AND GROUNDS MANAGEMENT DIVISION, CITY GENERAL SERVICES DEPARTMENT, QUEZON CITY GOVERNMENT.

WHEREAS, the position nomenclature of Mechanic II (SG-6) and Mechanic III (SG-9) positions under the Buildings and Grounds Management Division (BGMD), City General Services Department (CGSD), Quezon City Government are in accordance with the DBM index Occupational Services, Position Titles and Salary Grades (IOS), but do not conform with the Policies on the Grant of Eligibility of the Civil Service Commission;

WHEREAS, the said Mechanic positions have been part of the Plantilla of Position/Staffing Pattern of the City General Services Department since its creation up to present;

WHEREAS, the duties and responsibilities attached to subject positions have been expanded over the years with the introduction of new equipment and the rise of new buildings within the Quezon City Hall Compound;

WHEREAS, existing duties and responsibilities of Mechanic positions under the said Division are repairs and maintenance of mechanical equipment and air-conditioning facilities of the Quezon City Hall;

WHEREAS, the grant of eligibility for the said position in the Civil Service Commission is limited only to Mechanic (Automotive Servicing);

WHEREAS, there is a mismatched between the position nomenclature and its actual duties and responsibilities;

WHEREAS, appointments issued bearing the said nomenclature may have some technical and legal defects and unless amended, may meet CSC disapproval/invalidation;

WHEREAS, the said nomenclature of Mechanic positions have to be retitled to positions within the same occupational group of functionary related positions to cure the defects.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The following nomenclature of all Mechanic positions under the Buildings and Grounds Management Division (BGMD), City General Services Department (CGSD) shall be retitled as indicated hereunder:
