ORDINANCE NO. SP- 2423, S-2015

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF IPIL-IPIL HOMEOWNERS ASSOCIATION, INC. (PAYATAS) PHASE I WITH TWO HUNDRED NINE (209) SALEABLE LOTS. COMMUNITY MORTGAGE PROGRAM (CMP) ORIGINATED BY THE QUEZON CITY GOVERNMENT, LOCATED AT LOTS 2-C, 2-E, 2-F AND 2-H, PILI STREET GROUP 1, AREA B, BARANGAY PAYATAS, QUEZON CITY, METRO MANILA, REGISTERED IN THE NAME OF THE MANILA REMNANT CO., INC., COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBER N-322346, N-322348, N-322349 AND N-322351 OF THE REGISTRY OF DEEDS OF QUEZON CITY, CONTAINING AN AGGREGATE AREA OF TEN THOUSAND NINE HUNDRED EIGHTY-TWO (10,982) SQUARE METERS, AS APPLIED FOR BY ITS HOA PRESIDENT, MR. JAYSON ROY PAMPLONA, WITH OFFICE ADDRESS AT THE SAME PROJECT LOCATION, AS A VARIANCE PURSUANT TO SECTION 9, RULE III OF THE IMPLEMENTING STANDARDS, RULES AND REGULATIONS OF BATAS PAMBANSA BILANG 220.
