AN ORDINANCE RECLASSIFYING THE FOUR (4) LOTS UNDER THE SOCIALIZED HOUSING PROJECT OF THE QUEZON CITY GOVERNMENT (DIRECT SALE PROGRAM) LOCATED AT RUBY STREET, BARANGAY FAIRVIEW, QUEZON CITY, ALL REGISTERED IN THE NAME OF THE QUEZON CITY GOVERNMENT, THE DETAILS OF WHICH ARE AS FOLLOWS: LOT 1, BLOCK 55, PSD-00-070391, TCT NO. 337377 AND LOT 3, BLOCK 55, PSD-00-070391, TCT NO. 337379, FROM PARKS/PLAYGROUND INTO RESIDENTIAL AND LOT 4, BLOCK 53, PSD-00-070931, TCT NO. 337366 AND LOT 5, BLOCK 53, PSD-00-070931, TCT NO. 337367 FROM RESIDENTIAL INTO PARKS/PLAYGROUND.

WHEREAS, the members of Ruby Area B Open Space Neighbourhood Association, Inc. are the beneficiaries of a Socialized Housing Project of the Quezon City Government (Direct Sale Program) located at Ruby Street, Barangay Fairview, Quezon City;

WHEREAS, due to the proximity to the creek of two (2) residential lots, Ruby Area B Open Space Neighbourhood Association, Inc., in coordination with the Housing, Community Development and Resettlement Department (HCDRD), opted to transfer the affected families in the lots allocated for parks and playground and convert the lots they abandoned as the now existing parks and playground of the area.

## NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The Four (4) lots under the Socialized Housing Project of the Quezon City Government (Direct Sale Program) located at Ruby Street, Barangay Fairview, Quezon City, are hereby reclassified as follows:

- 3. Lot 4, Block 53, PSD-00-070931, TCT No. 337366 from Residential into Parks/Playground.
- 4. Lot 5, Block 53, PSD-00-070931, TCT No. 337367 from Residential into Parks/Playground.
