ORDINANCE NO. SP- 3099, S-2022

AN ORDINANCE APPROVING THE SUBDIVISION PLAN OF THE COMMUNITY MORTGAGE PROGRAM (CMP) PROJECT OF THE KABALIKAT NG BARANGAY HOMEOWNERS ASSOCIATION, INC., AS APPLIED FOR AND REPRESENTED BY ITS PRESIDENT, MS. JOSEFINA A. PIRA, WITH TWO HUNDRED THIRTY-TWO (232) SALEABLE LOTS COVERED BY TRANSFER CERTIFICATE OF TITLE NO. N-302662 OF THE REGISTRY OF DEEDS OF QUEZON CITY, CONSISTING OF SIXTEEN THOUSAND SIX HUNDRED SIXTY-SEVEN (16,667) SQUARE METERS AND LOCATED AT AREA 1-B, VETERANS VILLAGE, BARANGAY PASONG TAMO, DISTRICT VI, QUEZON CITY.

WHEREAS, the members of the association, composed of informal settler families (ISFs) who desire homeownership but have little means, are the actual occupants and awardees of lots embodied in the said CMP project originated by the Quezon City Government, through the Housing, Community Development and Resettlement Department (HCDRD);

WHEREAS, the said CMP project was taken out or approved on November 6, 1997 by the Social Housing Finance Corporation (SHFC) but the land title thereof has not yet been individualized or sub-divided to the members-beneficiaries of the association, hence, the need for the approval of the corresponding subdivision plan;

WHEREAS, the subject subdivision plan was favorably endorsed by the City Planning and Development Department and the Office of the City Administrator for approval by the City Council after a careful review and evaluation thereof;

WHEREAS, the approval of the subdivision plan of CMP project is in compliance with the minimum requirements of the Implementing Standards, Rules and Regulations of Quezon City Ordinance No. SP-56, S-93 and Batas Pambansa Bilang 220.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The Subdivision Plan of Community Mortgage Program (CMP) project of the Kabalikat ng Barangay Homeowners Association, Inc., as applied for and represented by its President, Ms. Josefina A. Pira, with two hundred thirty-two (232) saleable lots covered by Transfer Certificate of Title No. N-302662 of the Registry of Deeds of Quezon City, consisting of sixteen thousand six hundred sixty-seven (16,667) square meters and located at Area 1-B, Veterans Village, Barangay Pasong Tamo, District VI, Quezon City, is hereby APPROVED.
