ORDINANCE NO. SP-**3112**, S-2022

AN ORDINANCE CONVERTING THE LEANDRO LOCSIN INTEGRATED SCHOOL AND KALIGAYAHAN ELEMENTARY SCHOOL TO KALIGAYAHAN INTEGRATED SCHOOL LOCATED AT RIVERA COMPOUND, BARANGAY KALIGAYAHAN, NOVALICHES, QUEZON CITY.

WHEREAS, Section 1, Article XVI of the Philippine Constitution provides that "The State shall protect and promote the right of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all";

WHEREAS, Section 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local government units shall provide basic services and facilities including the establishment of school buildings;

WHEREAS, Leandro Locsin Integrated School and Kaligayahan Elementary School are located within the same vicinity or areas;

WHEREAS, in the letter of Mr. Joey S. Mancia Principal and other School Officers of both Schools to the School Divisions Office of Quezon City, which was received on November 22, 2021, they are requesting for the merging and renaming of the two schools in accordance with the provisions of DepEd Order No. 40, S-2014, entitled Establishment, Merging, conversion, and Naming/Renaming of Public Schools, and separation of School Annexes in Basic Education;

WHEREAS, the Local School Board signed Resolution No. 5, S-2021 for the conversion of the abovementioned school to Kaligayahan Integrated School;

WHEREAS, based from DepEd Revised Memorandum No. 253, S-2021 providing for the Revised Checklist for Application for Establishment, Merging, Conversion, and Renaming of Public Schools; and Separation of Public School Annexes in Basic Education, a local legislative act is needed for the purpose;

WHEREAS, based on 1st Indorsement dated December 2, 2021 signed by School Division Superintendent Dr. Jenilyn Rose B. Corpuz addressed to Education Affairs Office, Quezon City requesting for the drafting of city ordinance and recommending favorable action.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. CONVERSION. - Leandro Locsin Integrated School and Kaligayahan Elementary School, both located in Rivera Compound, Barangay Kaligayahan, Novaliches, Quezon City, are hereby converted and renamed under the School Division Office, Quezon City as the "Kaligayahan Integrated School."

SECTION 2. FUNDING. - The Supplemental funds necessary for the construction, maintenance and operation of the said public school, as determined by the Local School Board, shall be taken from the Special Education Funds of Quezon City or from any available funds of the City.

SECTION 3. REPEALING CLAUSE. - All previous ordinances, rules and regulations, or part thereof which are inconsistent with the foregoing are hereby modified, amended or repealed accordingly.

SECTION 4. SEPARABILITY CLAUSE. - If any part of the provisions of this Ordinance is held unconstitutional or invalid, other parts or provisions thereof which are not affected shall continue to remain in full force and effect.
