ORDINANCE NO. SP- 3129, S-2022

AN ORDINANCE INSTITUTIONALIZING THE GRANT OF INCENTIVES TO QUEZON CITY PUBLIC SCHOOL LEARNERS FOR ACADEMIC ACHIEVEMENT AND PUBLIC SERVICE.

WHEREAS, pursuant to Section 2 (3), Article XIV of the Philippine Constitution provides that the State shall establish and maintain a system of scholarship grants, student loan programs, subsidies and other incentives which shall be available to deserving students in both public and private schools, especially to the underprivileged;

WHEREAS, in line with the implementation of Republic Act No. 10533, otherwise known as the Enhanced Basic Education Act of 2013, the Local Government of Quezon City recognizes the outstanding performance and achievements of learners in academic and public service through student leadership;

WHEREAS, the Academic Achievers Award is a recognition for those Learners who obtained the top 3 highest general average in Grades 6 and 12 in all public elementary and secondary schools in Quezon City;

WHEREAS, the Joy of Public Service Award, through the City Mayor, Ma. Josefina “Joy” G. Belmonte, the Quezon City government awarded to the students that have shown exemplary commitment to the service of the school, its communities and its students. The recipient must also have shown interest in and genuine concern for social issues such as environmental protection and children’s rights and welfare. Overall, he/ she must be a role model of genuine leadership and must be worthy of emulation by others;

WHEREAS, the Quezon City Government institutionalizes these recognitions to encourage learners to strive for excellence and become proactive members of the school and community especially during extraordinary and challenging times.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. SHORT TITLE. - This Ordinance shall be known as the “Academic Achievers and Joy of Public Service Awards Ordinance.”

SECTION 2. DECLARATION OF POLICY. - It is the policy of the Quezon City Government to recognize exemplary academic achievements and public service through student leadership.

SECTION 3. OBJECTIVES. - This Ordinance shall have the following objectives:

- a. To recognize exemplary academic achievements and leadership of Grade 6 and Grade 12 graduating learners of Quezon City public schools.
- b. To encourage learners to strive for excellence and to become proactive members of the school and community especially during these extraordinary and challenging times.

INCENTIVES FOR TOP 3 GRADUATING LEARNERS

SECTION 4. INCENTIVES FOR TOP 3 GRADUATING LEARNERS. - Graduating learners with the highest general average in the Grade 6 and Grade 12 levels in public elementary and secondary schools shall be granted the following incentives.

INCENTIVES FOR JOY OF PUBLIC SERVICE AWARD

SECTION 5. INCENTIVES FOR JOY OF PUBLIC SERVICE AWARD. – It is hereby institutionalized to recognize students in the Grade 6 and Grade 12 levels who have aptly demonstrated the value of service above self by showing exemplary commitment to the service of the school, its communities and its students. The Joy of Public Service Awardees shall be granted the following incentives.

5.a For Grade Six (6) Graduating Student Php5,000.00

5.b For Grade Twelve (12) Graduating Student Php10,000.00

SECTION 6. APPROPRIATION. – The budgetary requirements shall be included in the annual appropriations of the General Fund.

SECTION 7. IMPLEMENTING OFFICE. - The Schools Division Office (SDO) of Quezon City shall be the main implementer of this Ordinance.

SECTION 8. IMPLEMENTING RULES AND REGULATIONS. - The Schools Division Office (SDO) of Quezon City shall issue the Implementing Rules and Regulations within sixty (60) days from the approval of this Ordinance for its effective implementation.

SECTION 9. SEPARABILITY CLAUSE. - If any part or section of this Ordinance is declared unconstitutional for any reason whatsoever such declaration shall not in any way affect other parts or sections of this Ordinance.
