WHEREAS, the City Mayor, Honorable Ma. Josefina G. Belmonte, has reappointed Engelbert Camonayan Apostol as City Government Department Head III (Chief Information Officer), with Salary Grade 27, at the Public Affairs and Information Services Department under a co-terminus appointment;

WHEREAS, Section 454 (d) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that "unless otherwise provided herein, heads of departments and offices shall be appointed by the city mayor with the concurrence of the majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations;

WHEREAS, Section 455 (b)(1)(v) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Local Chief Executive, acting as the Appointing Authority, shall "Appoint all officials and employees whose salaries and wages are wholly or mainly paid out of city funds and whose appointments are not otherwise provided for in this Code, as well as those he may be authorized by law to appoint";

WHEREAS, the said appointment was signed by the City Mayor on July 1, 2022 which shall take effect on the same date.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to confirm, as it does hereby confirm, the co-terminus appointment issued by the City Mayor, Honorable Ma. Josefina G. Belmonte, reappointing Engelbert Camonayan Apostol as City Government Department Head III (Chief Information Officer), with Salary Grade 27, at the Public Affairs and Information Services Department.
