AN ORDINANCE MAKING IT MANDATORY FOR ALL THE MEMBERS OF THE QUEZON CITY COUNCIL TO WEAR BARONG TAGALOG (FOR MALE) AND SIMPLE FILIPINIANA INSPIRED (FOR FEMALE) DURING COUNCIL SESSION FOR THE MONTH OF AUGUST IN OBSERVANCE OF THE "BUWAN NG WIKANG PAMBANSA."

WHEREAS, Section 6, Article XIV of the 1987 Philippine Constitution provides, in part, that:

“xxx the Government shall take steps to initiate and sustain the use of Filipino as a medium of official communication and as a language of instruction in the educational system.”

WHEREAS, on January 5, 1997, then President Fidel V. Ramos issued Proclamation No. 1041, Series of 1997 declaring August 1-31 as *Buwan ng Wikang Pambansa*;

WHEREAS, in harmony with the said celebration, the City Council has made it a practice during the entire month of August to hold session using Filipino as a medium of official communication;

WHEREAS, to make the month-long festivity more meaningful, historic and significant, it is but proper for the Members of the City Council to wear *Barong Tagalog* and simple *Filipiniana* inspired that would highlight its Filipino identity in accord with the use of Filipino language as a medium of official communication.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The Members of the Quezon City Council are hereby required to wear *Barong Tagalog* for male and simple *Filipiniana* inspired for female during the Council Session for the month of August in observance of the “*Buwan ng Wikang Pambansa*.”

SECTION 2. A violation of this ordinance may be used as a ground for disciplinary action against the said member or members of the City Council in accordance with the provisions of the existing Internal Rules of Procedure of the Quezon City Council.


SECTION 3. This Ordinance shall take effect immediately upon its approval.


