ORDINANCE NO. SP- **3143**, S-2022

AN ORDINANCE IMPOSING ONE PESO (PHP1.00) INCREASE TO THE ADMISSION FEES IN ALL CINEMAS IN QUEZON CITY COVERING THE PERIOD FROM NOVEMBER 1 TO 30, 2022, THE PROCEEDS THEREOF ARE TO BE DONATED TO THE RED CROSS OF THE PHILIPPINES, QUEZON CITY CHAPTER, TO SUPPORT ITS NUMEROUS PROGRAMS AND ACTIVITIES.


NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:


SECTION 1. Admission Fees in all cinemas/movie houses in Quezon City are hereby increased by One Peso (Php1.00) for the period of November 1 to 30, 2022.

SECTION 2. All concern movie/cinema owners and operators are hereby authorized to transmit and turn over to the Philippine Red Cross - Quezon City Chapter all sums of money collected, and the Philippine Red Cross Quezon City Chapter will account for all such money received and submit to the City Treasurer of Quezon City official receipts and such other pertinent records as maybe required in the acknowledgement thereof, subject to the usual accounting report to the City Council in connection therewith.
