RESOLUTION NO. SP- 9042, S-2022

A RESOLUTION EXPRESSING THE 22ND CITY COUNCIL'S PROFOUND CONGRATULATIONS TO THE CITY MAYOR, HONORABLE MA. JOSEFINA "JOY" G. BELMONTE, FOR HER WELL-DESERVED CONFERMENT OF THE GABRIELA SILANG OF THE FIRST ORDER AWARD AND EXTOLLING THE QUEZON CITY GOVERNMENT'S HUMANITARIAN EFFORTS TOWARDS AMELIORATING THE SUFFERINGS OF OUR FELLOW FILIPINOS IN DISASTER-STRICKEN LOCAL GOVERNMENT UNITS.

WHEREAS, immediately after a 7.0-magnitude earthquake that struck the province of Abra and contiguous areas in northern Luzon last July 2022, the Quezon City Government, at the initiative of Honorable Mayor Ma. Josefina "Joy" G. Belmonte, promptly extended humanitarian assistance to our fellow Filipinos who were affected by the calamity;

WHEREAS, the Quezon City Government, composed of teams from the Quezon City Disaster Risk Reduction and Management Office (DRRMO), Social Services Development Department (SSDD), and City Health Department (CHD), conducted a building inspection and damage assessment in the affected areas, gave psychological support to the first responders and others impacted by the disaster, and gave out hot meals and camp management supplies to evacuees and displaced families of the earthquake;

WHEREAS, in the aftermath of the disaster, Honorable Mayor Ma. Josefina "Joy" G. Belmonte affirmed the Quezon City's readiness to provide mutual aid and assistance to victims of disasters in other localities, saying that "kami [...]sa Pamahalaang Lungsod Quezon ay handang mag-abot ng tulong sa mga probinsya at lungsod na higit na nangangailangan";

WHEREAS, indeed, the efforts of Honorable Mayor Ma. Josefina "Joy" G. Belmonte have been broadly praised and lauded as an example of model leadership and compassionate governance, as these quick and resolute actions reflected the Filipino values of "bayanihan" and "damayan," especially during times of hardship and suffering;

WHEREAS, in view of the humanitarian gesture, Honorable Mayor Ma. Josefina "Joy" G. Belmonte was conferred with the Gabriela Silang of the First Order Award—an honor of exceptional prestige that rightfully deserves the profound congratulations of the 22nd Sangguniang Panlungsod of Quezon City, as the same is likewise a recognition of the City's selflessness and readiness to ameliorate the sufferings of fellow Filipinos during times of extreme hardship and suffering—no matter how far they may be;

WHEREAS, this honor also recognizes and concretizes our beloved Quezon City's leadership role in disaster risk reduction and management among more than 1,600 local government units (LGUs) in the Philippines, especially with respect to the expertise and experience that its offices and public servants have gathered over the years and the city resources that are ready for immediate utilization and mobilization;

WHEREAS, this leadership role of the Quezon City Government among LGUs redounds to the benefit of the Filipino People as a whole and its recent actions in northern Luzon highlight Quezon City's generous and active contribution to the betterment of the Filipino Nation.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to express, as it does hereby express, the 22nd City Council's profound congratulations to the City Mayor, Honorable Ma. Josefina "Joy" G. Belmonte, for her well-deserved conferment of the Gabriela Silang of the First Order Award and extolling the Quezon City Government's humanitarian efforts towards ameliorating the sufferings of our fellow Filipinos in disaster-stricken local government units.

RESOLVED FURTHER, that the City Council of Quezon City extols the Office of the City Mayor and the Quezon City Government's efforts towards ameliorating the sufferings of our fellow Filipinos in disaster-stricken provinces, cities, and municipalities, supporting as it does actions like the quick initiatives undertaken by the City Mayor, Honorable Ma. Josefina "Joy" G. Belmonte, after the July 2022 northern Luzon earthquake.


