ORDINANCE NO. SP. 3155, S-2022

AN ORDINANCE IMPOSING A ONE PESO (PHP1 00) INCREASE ON THE ADMISSION FEES IN ALL CINEMAS IN QUEZON CITY FOR THE MONTH OF FEBRUARY 2023, THE PROCEEDS THEREOF ARE TO BE DONATED TO THE BOY SCOUTS OF THE PHILIPPINES-QUEZON CITY COUNCIL, TO SUPPORT ITS NUMEROUS PROGRAMS, PROJECTS, AND ACTIVITIES.

WHEREAS, the Boy Scouts of the Philippines-Quezon City Council has various programs, projects, and activities that need continued assistance from the city government to strengthen the scouting movement in the Philippines;

WHEREAS, as a manifestation of its support to the BSP-Quezon City Council, the City Government is desiring to increase the admission fees in all cinemas of Quezon City by One Peso (Php1.00) to pave the way for the realization of the Boy Scout's mission and vision;

WHEREAS, among the vital activities being conducted by the BSP-Quezon City Council are those which are geared towards the promotion of moral, spiritual, and physical well-being of the youth, the development of sports and livelihood programs, protection and preservation of the environment, promotion of waste management programs, and community development of Quezon City:

WHEREAS, the BSP-Quezon City Council is also actively involved in character development, providing adequate citizenship training and leadership among the Filipino youth of the city, and in inculcating in them love of country, civic consciousness and responsibility, courage and discipline, and similar other virtues and moral values.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. The admission fees in all cinemas/movie houses in Quezon City are hereby increased by One Peso (Php1.00) for the month of February 2023.

SECTION 2. All owners and operators of cinemas/movie houses in Quezon City shall transmit and turn-over to the Quezon City Government all sum of money received or collected by virtue of this ordinance to be donated to the Boy Scouts of the Philippines-Quezon City Council.

SECTION 3. The Boy Scouts of the Philippines-Quezon City Council shall make a proper accounting of the total amount they received, as well as the expenses incurred, with official receipts and pertinent documents to be submitted to the City Treasurer's Office of Quezon City, subject to the usual government accounting and auditing rules. The City Treasurer, in this connection, is hereby directed to submit the corresponding report to the City Council within ten (10) days from receipt of the said pertinent documents.

SECTION 4. Upon approval, a copy of this Ordinance shall be furnished to the Boy Scouts of the Philippines-Quezon City Council, the City Treasurer's Office, and to all the owners/operators of cinemas/movie houses doing business in Quezon City, for their information, guidance, and proper action.
