WHEREAS, the Philippine Business for Education, Inc. (PBeD) is a non-stock and non-profit corporation led by the business community to promote sustained and strategic education reform in the Philippines;

WHEREAS, PBeD has a local pilot project called "JobsNext" supported by the City Foundation to ensure the employability of the Filipino youth through industry-relevant, demand-driven, up-to-date, and appropriate skilling programs for jobs of the future;

WHEREAS, PBeD, in partnership with the Quezon City local government, will have the pilot implementation of "JobsNext" in the City from October 24, 2022 to June 30, 2023, with monitoring and evaluation activities until September 30, 2023;

WHEREAS, the partnership among the parties cover, among others, the recruitment of youth trainee candidates as project beneficiaries, conduct of skills training, provisions of subsidies, private sector engagement, and provision of employment opportunities to project beneficiaries;

WHEREAS, this partnership promotes cooperation with the academe, local government, and private sector to enhance the access of unemployed and out-of-school Filipino youth to quality training and employment opportunities.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City Government, represented by the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter and sign a Memorandum of Agreement with the Philippine Business for Education, Inc., represented by its Executive Director, Ms. Justine Raagas, for the local pilot implementation of the JobsNext Project, subject to existing laws, rules, and regulations.
