A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT THROUGH THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH MIRIAM COLLEGE AND THE SCHOOLS DIVISION OFFICE FOR THE FREE ACCESS TO ONLINE MENTAL HEALTH RESOURCES FOR PUBLIC SCHOOL TEACHERS AND GUIDANCE COUNSELORS AND ADVOCATES.

WHEREAS, Miriam College intends to provide public school teachers, guidance counselors, and advocates free access to online mental health resources;

WHEREAS, through the online mental health resources, participants will be equipped with the necessary information and activities designed to raise awareness, facilitate early detection, and reduce risks associated with poor mental health. The online resources will also include key messages targeting elementary and high school students. These messages were developed through the perspectives of the teachers, parents, and students and are meant to enhance their wellness and personal peace;

WHEREAS, the mental health webinar series, inclusive of 10 sessions, shall include topics on Physical Wellness, Emotional Wellness, Intellectual Wellness, Social Wellness, Occupational/Financial Wellness, Environmental Wellness, Spiritual Wellness, and three (3) special topics;


