AN ORDINANCE AMENDING THE PENALTIES FOR VANDALISM AND/OR DEFACEMENT OF WALLS, FENCES AND/OTHER SURFACES, AS PRESCRIBED UNDER CITY ORDINANCE NUMBER 3433, S-57.

WHEREAS, Ordinance Number 3433, S-57 is a 1957 ordinance and thus needs an update to keep up with the changing times;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Section 2 of City Ordinance No. 3343, S-57 is hereby amended to read as follows:

"Section 2. For violations of this Ordinance, the offender shall be liable:

For the 1st offense - Fine of One Thousand Pesos

(Php1,000.00).

For the 2nd offense - Fine of Two Thousand Pesos

(Php2,000.00).

For the 3rd offense - Fine of Three Thousand Pesos

(Php3,000.00).

In addition, the offender shall also be liable for the expenses incurred for the restoration of the defaced and/or vandalized wall, fence and/or other surface."

SECTION 2. This Ordinance shall take effect immediately after complying with the requisite publication.
