A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE TO BE USED BY THE OFFICE OF COUNCILOR SHAIRA "Shay" L. LIBAN, 5TH DISTRICT OF QUEZON CITY, FOR THE IMPLEMENTATION AND MONITORING OF VARIOUS PROJECTS AND PROGRAMS IN THE AMOUNT OF TWO MILLION FOUR HUNDRED FIFTY THOUSAND PESOS (PHP2,450,000.00) TO BE CHARGED AGAINST THE GENERAL FUND OF THE OFFICE OF THE CITY ADMINISTRATOR, SUBJECT TO EXISTING LAWS AND REGULATIONS.




