RESOLUTION NO. SP- **9189**, S-2023

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO DONATE THE ONE HUNDRED FORTY-TWO (142) UNITS AMBULANCE SET-UP VANS (PATIENT TRANSPORT VEHICLE) WITH EQUIPMENT TO ALL BARANGAYS OF THE QUEZON CITY GOVERNMENT, AND TO TRANSFER ITS OWNERSHIP TO THE RECIPIENT BARANGAYS WITHOUT COST, SUBJECT TO EXISTING LAWS AND REGULATIONS.

WHEREAS, Section 17(a) of Republic Act No. 7160 otherwise known as the Local Government Code of 1991, dealing with Basic Services and Facilities, provides that Local Government Units shall endeavor to be self-reliant and shall continue exercising the power and discharging the duties and functions currently vested upon them. They shall also discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local government units shall likewise exercise such other functions and responsibilities as are necessary, appropriate or incidental to efficient and effective provision of the basic services and facilities enumerated herein;

WHEREAS, the City Government is empowered under Section 458(1)(iv) of the same Code to adopt measures to protect the inhabitants of the City from harmful effects of man-made or natural disasters and calamities, to provide relief services and assistance to victims during and in the aftermath of said disasters or calamities, and to facilitate their return to productive livelihood following said events;

WHEREAS, in keeping with the aforesaid provisions, the Quezon City Government, through its Disaster Risk Reduction and Management Program, purchased one hundred sixty (160) Ambulance Set-up Vans (Patient Transport Vehicle) with Equipment to be used as Emergency Vehicles to provide quick response and relief services to those who need assistance;

WHEREAS, the 160 Ambulance Set-up Vans (Patient Transport Vehicle) with Equipment were issued/distributed to the Quezon City Disaster Risk Reduction and Management Department, Bureau of Fire Protection, Quezon City Police District, Quezon City Health Department, Quezon City General Hospital, Rosario M. Bautista General Hospital, Novaliches District Hospital and 142 Barangays of Quezon City;

WHEREAS, considering that the said Barangays are solely the end-users of these ambulances, the donation of these 142 units of Ambulance Set-up Vans (Patient Transport Vehicle) with Equipment to the Barangays is imperative since it will not only cause the transfer of ownership from the Quezon City Government to the Barangays, but will also relieve the Quezon City Government from payment of insurance premiums and registration fees, including the tedious insurance claims processes incident to the utilization of these ambulances. In the same manner, the Barangays will be responsible for its maintenance and ensure that the units are properly utilized;

WHEREAS, hereunder is the list of the 142 Ambulance Set-up Vans (Patient Transport Vehicle) with Equipment with their Motor/Chassis Numbers and Conduction Stickers issued to the corresponding Barangay:



NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to donate the one hundred forty-two (142) units Ambulance Set-up Vans (Patient Transport Vehicle) with Equipment to all barangays of the Quezon City Government, and to transfer its ownership to the recipient barangays without cost, subject to existing laws and regulations.
