A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH-METRO MANILA CENTER FOR HEALTH DEVELOPMENT (DOH-MMCHD) INTENDED FOR UPGRADING, REHABILITATION, REPAIR, CONSTRUCTION AND FOR COMPLETION OF REPUBLIC HEALTH CENTER, QUEZON CITY WATER LABORATORY, AND P. BERNARDO SOCIAL HYGIENE CLINIC AND SUNDOWN KLINIKA.

WHEREAS, the Department of Health-Metro Manila Center For Health Development (DOH-MMCHD) is mandated to ensure the provision of equitable and accessible quality healthcare for all Filipinos through the Health Facilities Enhancement Program (HFEP);

WHEREAS, the aim of the HFEP is to achieve the country's overall health system goals which are mainly to improve health outcomes, provide financial risk protection and responsiveness. The HFEP is guided by the Department of Health's FOURmula One Plus for Health (F1 plus) for the implementation of Republic Act No. 11223, otherwise known as the "Universal Health Care Law";

WHEREAS, the approved budget for the Health Facilities Enhancement Program (HFEP) under Republic Act No. 11639, otherwise known as the "General Appropriation Act (GAA) of 2022", is apportioned for the construction, upgrading or expansion of the government health care facilities such as DOH Hospitals, Local Government Unit (LGU) Hospitals, Rural Health Units (RHU) and Barangay Health Station (BHS). The budget also includes the procurement of medical equipment and motor vehicles for health care facilities to ensure that each facility can respond to the health needs of the people;

WHEREAS, the Department of Health has appropriated the amount of Fifty-Seven Million Five Hundred Thousand Pesos (Php57,500,000.00) for the upgrading, rehabilitation, repair, construction and/or completion of the following health facilities, to be undertaken by the Quezon City Government, to wit:

Health Facility	Allocation (Php)
1. Republic Health Center	11,500,000.00
2. Quezon City Water Laboratory	11,500,000.00
3. P. Bernardo Social Hygiene Clinic and Sundown Klinika	34,500,000.00
TOTAL	Php57,500,000.00

WHEREAS, the Department of Health-Metro Manila Center for Health Development (DOH-MMCHD) shall transfer the funds to Quezon City Government and shall use the same for the implementation of the project wherein the City government undertakes to comply with the responsibilities enumerated under letter C thereof, including the necessary Council Resolution authorizing the City Mayor to enter into an agreement with DOH-MMCHD;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with the Department of Health-Metro Manila Center for Health Development (DOH-MMCHD) intended for upgrading, rehabilitation, repair, construction and for completion of Republic Health Center, Quezon City Water Laboratory, and P. Bernardo Social Hygiene Clinic and Sundown Klinika.
