AVENUE CORNER MATIMYAS STREET, BARANGAY DON MANUEL, GALAS, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, Faro Alto International Trading Corporation, a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by Mr. Earlwood Y. Tan, with business address at M1 Central, E. Rodriguez Sr. Avenue corner Matimyas Street, Barangay Don Manuel, Galas, Quezon City, Metro Manila, is applying for the renewal of Special Permit to operate Bingo Games;

WHEREAS, the said Applicant-Corporation was previously granted Special Permit by the Quezon City Council for the operation of the same business through Resolution No. SP-8114, S-2020;

WHEREAS, to enable the Applicant-Corporation to continue its business operations, there is a need to renew its Special Permit;

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended by Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorizes the City Council to grant or renew Special Permits to business activities, such as the operation of Bingo Games;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of Faro Alto International Trading Corporation to operate Bingo Games at M1 Central, E. Rodriguez Sr. Avenue corner Matimyas Street, Barangay Don Manuel, Galas, Quezon City, subject to the Rules and Regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate Bingo Games granted herein shall be subject to the following conditions:

1. The holding of Bingo Games shall be in accordance with the Rules and Regulations promulgated by PAGCOR.
2. The operation of Bingo Games shall not include playing of other games which are not related to Bingo.
3. Individuals below eighteen (18) years of age should be prohibited from playing in the above-mentioned games.
