A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH BUREAU OF JAIL MANAGEMENT AND PENOLOGY, THE PHILIPPINE FASHION COALITION, FASHION ACCESSORY MAKERS OF THE PHILIPPINES (FAMPh), FOR THE PROUDLY ORIGINAL PRODUCT OF QUEZON CITY KOLAB (POP QC KOLAB) PROJECT.

*WHEREAS, the Quezon City Government aims to bring government services closer to the people and deliver basic services more efficiently by promoting partnership with other agencies and private organizations;*

*WHEREAS, the Quezon City Government, through the QC Small Business and Cooperatives Development and Promotions Office (QC-SBCDPO), provides training, capital assistance, marketing, and livelihood opportunities to QCitizens for the growth and sustainable development of the City's Micro/Small Enterprises and Cooperatives (MSECs);*

WHEREAS, the QC-SBCDPO coordinated with Philippine Fashion Coalition (PFC), a coalition of creatives, artisans, and designers of the Philippines; and Fashion Accessory Makers of the Philippines (FAMPh), a business-support organization of fashion accessory designers and manufacturers, to identify local designers that can participate in the project;

WHEREAS, the QC-SBCDPO, coordinated with Bureau of Jail Management and Penology - Quezon City Jail Female Dormitory (BJMP-QCJFD), to identify female inmates or PDLs that can be trained and mentored as local community artisans for them to get skills that can be integrated in BJMP's livelihood program;

WHEREAS, the Quezon City Government, BJMP, PFC, and FAMPh agree to establish a project/initiative called Proudly Original Product of Quezon City KOLAB (POP QC KOLAB) that will match local fashion designers with local community artisans of Quezon City in upgrading their craft and to showcase the artistry and innovation of products in Quezon City;

WHEREAS, the Quezon City Government, BJMP, PFC, and FAMPh agree that a concerted effort among government and private organizations for this project will greatly benefit micro entrepreneurs and local community artisans in Quezon City;

WHEREAS, there is a need for the City Council to grant authority to the City Mayor before signing the Memorandum of Understanding for and in behalf of the Quezon City Government;

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of Sangguniang Panlungsod or pursuant to law or ordinance.
