WHEREAS, Wilcon Depot, Inc., is applying for a Special Use Permit for the construction and operation of two (2) Helipads (As Built) to the Three (3)-Storey Commercial Building with Basement (Wilcon Depot Commonwealth), located at Lot 946-A Feria Road, Barangay Matandang Balara, District III, Quezon City;

WHEREAS, pursuant to the provisions of the existing Quezon City Zoning Ordinance, the use of heliports/helipads are among those which require the issuance of a Special Use Permit upon authorization from the Quezon City Council;
