RESOLUTION NO. SP- 9236, S-2023

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO DYNAMIC SPACE HOLDINGS, INC./IVAN A. YAO FOR THE CONSTRUCTION AND OPERATION OF A PROPOSED SIXTEEN (16)-STOREY COMMERCIAL BUILDING, WITH MEZZANINE, LOFT (6TH-9TH FLOORS), BASEMENT AND ROOF DECK (ONE LITE TOWER), WHICH SHALL BE LOCATED AT LOTS 7-I-3 AND 7-I-4, BLOCK 10, MIRASOL STREET CORNER 20TH AVENUE, BARANGAY SAN ROQUE, DISTRICT III, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016

WHEREAS, Dynamic Space Holdings, Inc./Ivan A. Yao is applying for the issuance of a Certificate of Exception for the construction and operation of a Proposed Sixteen (16)-Storey Commercial Building, with Mezzanine, Loft (6th-9th Floors), Basement and Roof Deck (One Lite Tower), which shall be located at Lots 7-I-3 and 7-I-4, Block 10, Mirasol Street corner 20th Avenue, Barangay San Roque, District III, Quezon City;

WHEREAS, in accordance with the provisions of Section 55, Article VIII, in relation to Sections 71 and 73, Article IX of Ordinance No. SP-2502, S-2016, an exception or deviations from the provisions of Zoning Ordinance may be allowed only upon authorization from the City Council;

WHEREAS, the proposed project will not adversely affect public health, safety, and welfare and is in keeping with the general pattern of development in the community;


WHEREAS, the Sangguniang Barangay and the homeowners concerned have interposed no objection to the said project;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Certificate of Exception to Dynamic Space Holdings, Inc./ Ivan A. Yao for the construction and operation of a Proposed Sixteen (16)-Storey Commercial Building, with Mezzanine, Loft (6th-9th Floors), Basement and Roof Deck (One Lite Tower), which shall be located at Lots 7-I-3 and 7-I-4, Block 10, Mirasol Street corner 20th Avenue, Barangay San Roque, District III, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
