A RESOLUTION DONATING ONE HUNDRED SIXTY-SEVEN (167) UNITS OF TENTS TO ALL THIRTY-SEVEN (37) BARANGAYS OF THE 1ST DISTRICT OF QUEZON CITY, AND AUTHORIZING THE TRANSFER OF OWNERSHIP OF THE SAME TO THE RECIPIENTS WITHOUT COST

Delarmente, M.D.;

WHEREAS, to effectively turn over the ownership of the said tents to the recipients without cost, a Deed of Donation shall be executed with all the fees and costs to be assumed by the City.
