A RESOLUTION RENEWING THE SPECIAL PERMIT OF JACBINGO CORPORATION TO OPERATE A BINGO CENTER/HALL AT JACKMAN PLAZA MUÑOZ LOCATED AT NO. 1038 EDSA, BARANGAY RAMON MAGSAYSAY, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, the said applicant was previously granted a Special Permit by the City Council for the operation of the same business through Resolution No. SP-7342, S-2018;

WHEREAS, there is a need to renew the Special Permit to enable the applicant to continue its business operations;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to existing City ordinances, authorizes the City Council to grant or renew a Special Permit to do business activity of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of JacBingo Corporation to operate a Bingo Center/Hall at Jackman Plaza Muñoz located at No. 1038 EDSA, Barangay Ramon Magsaysay, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate Bingo/Center Hall at Jackman Plaza Muñoz located at No. 1038 EDSA, Barangay Ramon Magsaysay, Quezon City, granted herein, shall be subject to the following conditions:

- a. The holding of Bingo Center/Hall shall be in accordance with the rules promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR);
- b. The operation of Bingo/Center Hall shall not include the playing of other games not related to Bingo; and
- c. The operator is enjoined to prohibit individuals below eighteen (18) years of age from playing in the above-mentioned games.
