*WHEREAS, Gamexperience Entertainment Corporation is a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, and with business address at Ground Floor, Greenhills Town Center, Granada Street corner Valencia Street, Barangay Valencia, District IV, Quezon City;*

*WHEREAS, Gamexperience Entertainment Corporation is engaged in the business of Electronic Bingo and Traditional Bingo;*

*WHEREAS, the applicant was previously granted a Special Permit by the Quezon City Council for the operation of the same business through Resolution No. SP-7894, S-2019;*

*WHEREAS, to enable the applicant to operate Electronic Bingo and Traditional Bingo in Quezon City, there is a need to secure a Special Permit from the City Council pursuant to Ordinance No. SP-2773, S-2018, in relation to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;*

*WHEREAS, the operation of Electronic Bingo and Traditional Bingo is regulated and licensed by the Philippine Amusement and Gaming Corporation;*

*WHEREAS, Gamexperience Entertainment Corporation is requesting the City Council to grant a renewal of its Special Permit to operate Electronic Bingo and Traditional Bingo.*

**NOW, THEREFORE,**

**BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED,** to renew, as it does hereby renew, the Special Permit of Gamexperience Entertainment Corporation to operate Electronic Bingo and Traditional Bingo at Ground Floor, Greenhills Town Center, Granada Street corner Valencia Street, Barangay Valencia, District IV, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

**RESOLVED FURTHER,** that Gamexperience Entertainment Corporation shall remit to the City Treasurer's Office a franchise fee of three percent (3%) of the gross revenue of herein grantee, which shall be made payable yearly to the City Treasurer's Office during the lifetime of this Resolution.
