A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO EXECUTE AND SIGN THE DEED OF DONATION AND ACCEPTANCE WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) FOR THE DONATION OF SIX (6) UNITS OFF-SITE MODULAR DORMITORY LOCATED AT THE QUEZON CITY MEMORIAL CIRCLE

WHEREAS, in response to the pandemic crisis brought about by COVID-19, the Department of Public Works and Highways (DPWH) and the Quezon City Government agreed to establish and operate an Off-Site Modular Dormitory to be named as "We Heal As One Off-Site Dormitory For Medical Personnel" for the purpose of providing a shelter place for Quezon City frontliners and other healthcare workers working for the Quezon City Government Hospitals, Health Centers, Testing Centers and Quarantine Facilities (HOPE), and National Government Hospitals within the territorial jurisdiction of Quezon City;

WHEREAS, by virtue of the Memorandum of Agreement dated July 17, 2020, the abovementioned Off-Site Dormitory, which is the property of DPWH, may be dismantled or removed on site after the pandemic if found to be no longer necessary;

WHEREAS, the parties also agreed that the operation of the said Off-Site Modular Dormitory shall be undertaken by the Quezon City Government with the assistance of the Department of Health, in so far as health standards and health protocols are concerned;

WHEREAS, the Quezon City Government, through a Letter dated 09 December 2022, requested for the official donation of the constructed Off-Site Dormitories for the benefit of the Quezon City community to be utilized in other locations, wherever temporary structures and resettlement facilities are needed;

WHEREAS, the DPWH, in donating the Off-Site Modular Dormitory, finds the Quezon City Government to be in a better position to utilize and conduct the necessary maintenance and dismantling works on the same for the benefit of the health workers and the citizens of Quezon City;

WHEREAS, for and in consideration of the request for the official donation of the Off-Site Modular Dormitory to Quezon City Government and the desire of the DPWH to provide the needed assistance considering the benefit of maximizing the utilization of the constructed modular health facilities, the DPWH, including its successors and assigns, are made free and clear of any and all liens and encumbrances, whatsoever, as to all its rights, interest, and title on the six (6) units Off-Site Modular Dormitory located at Quezon City Memorial Circle (QMC) upon donation of the same to the Quezon City Government;

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to execute and sign the Deed of Donation and Acceptance with the Department of Public Works and Highways (DPWH) for the donation of six (6) units Off-Site Modular Dormitory located at the Quezon City Memorial Circle.
