WHEREAS, Manila Klean Fuel Corp., a duly registered business entity under Philippine laws, and through their Vice President Mr. Ralph S. Atienza, is applying for the issuance of a Special Use Permit (SUP) for the construction and operation of Clean Fuel Gasoline Refilling Station located at Lots 1 and 2, Block 236, Commonwealth Avenue corner Mindanao Avenue, Barangay Pasong Putik Proper, District V, Quezon City;

WHEREAS, the proposed project is permissible to the zone classification; however, Gasoline Refilling Station is among the uses which require a Special Use Permit upon authority from the Quezon City Council as provided in Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;
