A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ACQUIRE THROUGH NEGOTIATED SALE AND TO EXECUTE A DEED OF ABSOLUTE SALE FOR THE PURCHASE OF PARCELS OF LAND COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERS 004-2022013858, 004-2022013859, 004-2022013860, 004-2022013861, 004-2021007380, 004-2022008232 AND 004-2022008233, REGISTERED UNDER THE NAME OF SWEET HAVEN LAND DEVELOPERS, INC., WITH AN AGGREGATE AREA OF NINETEEN THOUSAND FIVE HUNDRED SEVENTY-FIVE (19,575) SQUARE METERS, MORE OR LESS, LOCATED AT DINORADO STREET, BARANGAY BAGONG SILANGAN, DISTRICT II, QUEZON CITY, INTENDED FOR THE DEVELOPMENT OF A SOCIALIZED HOUSING PROJECT FOR THE BENEFIT OF QUEZON CITY'S INFORMAL SETTLER FAMILIES (ISFs)

WHEREAS, the Quezon City Government, through the Housing, Community Development and Resettlement Department (HCDRD), in its desire to provide greater opportunities to a significant number of Quezon City informal settlers/residents to own an in-city, decent, and affordable housing, has been relentless in its efforts to expand its socialized housing projects;

WHEREAS, in support of the Quezon City Government's objective, Sweet Haven Land Developers, Inc., the owner of the parcels of land covered by Transfer Certificates of Title Numbers 004-2022013858, 004-2022013859, 004-2022013860, 004-2022013861, 004-2021007380, 004-2022008232 and 004-2022008233, with an aggregate area of Nineteen Thousand Five Hundred Seventy-Five (19,575) square meters, more or less, located at Dinorado Street, Barangay Bagong Silangan, District II, Quezon City, has expressed willingness to sell the above-described parcels of land to the Quezon City Government through a negotiated sale;

WHEREAS, the purpose of acquiring the above-described properties is to develop the same into a socialized housing project for the benefit of the Quezon City's ISFs who will be screened and pre-qualified by a Beneficiary Selection Committee;

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to acquire through negotiated sale and to execute a Deed of Absolute Sale for the purchase of parcels of land covered by Transfer Certificates of Title Numbers 004-2022013858, 004-2022013859, 004-2022013860, 004-2022013861, 004-2021007380, 004-2022008232 and 004-2022008233, registered under the name of Sweet Haven Land Developers, Inc., with an aggregate area of nineteen thousand five hundred seventy-five (19,575) square meters, more or less, located at Dinorado Street, Barangay Bagong Silangan, District II, Quezon City, intended for the development of a socialized housing project for the benefit of Quezon City's informal settler families (ISFs).
