A RESOLUTION AMENDING RESOLUTION NO. SP-9121, S-2022, ENTITLED "A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO AND SIGN A UNIFIED MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT – NCR DULY REPRESENTED BY ITS REGIONAL DIRECTOR MONINA JOSEFINA H. ROMUALDEZ, SUBJECT TO COMPLIANCE TO ALL LAWS AND EXISTING LEGAL RULES AND REGULATIONS FOR THE IMPLEMENTATION OF SOCIAL PROTECTION PROGRAMS AND PROJECTS IN THE QUEZON CITY", BY REPLACING THE NAME OF THE DSWD-NCR DIRECTOR TO MICHAEL JOSEPH J. LORICO

WHEREAS, the Department of Social Welfare and Development (DSWD) is the government agency that is primarily responsible in delivering coordinated social protection services aimed at eradicating poverty;

WHEREAS, DSWD envisions a society where the poor, vulnerable and disadvantaged individuals, families and communities are empowered through the implementation of various projects, programs and activities, collectively referred to as "Social Protection", for an improved quality of life;

WHEREAS, the City Government intends to address poverty within the City through the implementation of programs, locally generated or in coordination with National Government Agencies (NGAs);

WHEREAS, the City Government, which recognizes that a partnership with DSWD will contribute in the attainment of the program objectives and will bring forth reduced poverty within the City, acknowledges that the projects implemented by the NGAs are designed to deliver coordinated social protection services and are meant to address poverty;

WHEREAS, on December 12, 2022, the Quezon City Council has adopted Resolution No. SP-9121, S-2022 granting authority to the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into and sign a Unified Memorandum of Agreement with the Department of Social Welfare and Development Office – NCR duly represented by its Regional Director Monina Josefina H. Romualdez, subject to compliance to all laws and existing legal rules and regulations for the implementation on social protection programs and projects in the Quezon City;

WHEREAS, the City Mayor is authorized to enter into a Unified Memorandum of Agreement with DSWD for strengthened partnership and for a more effective implementation of social protection programs, projects, and activities, such as the Social Pension for Indigent Senior Citizens, aimed at eradicating poverty;

WHEREAS, there is a need to amend Resolution No. SP-9121, S-2022 since former Regional Director Monina Josefina H. Romualdez has been replaced by Michael Joseph J. Lorico as the Officer-in-Charge;

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.
