VELOSO, FOR THE DEVELOPMENT OF THE GSIS HOUSING PROGRAM IN QUEZON CITY THAT WILL PROVIDE ACCESSIBLE AND AFFORDABLE HOUSING UNITS FOR ITS MEMBERS

WHEREAS, one of the top priorities of the Quezon City Government (QCG) is to provide opportunities for its constituents and employees to own affordable and decent housing, and upgrade the living conditions in blighted areas by developing said areas into a decent and productive communities;

WHEREAS, in support of the "Pambansang Pabahay Para sa Pilipino Program" of President Marcos, Jr., and in line with the mandate of Government Service Insurance System (GSIS) to provide housing for its members, GSIS is set to launch a national housing program (hereinafter, "GSIS Housing Program") that will provide accessible and affordable housing units for its members nationwide;

WHEREAS, to jumpstart the GSIS Housing Program, GSIS has identified lots within Barangay Fairview, Quezon City for development of Medium-Rise Buildings (MRBs) that will serve the housing needs of GSIS members, especially those residing and working within Quezon City and neighboring cities within Metro Manila;

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with the Government Service Insurance System (GSIS), represented by its President and General Manager Jose Arnulfo A. Veloso, for the development of the GSIS Housing Program in Quezon City that will provide accessible and affordable housing units for its members.
