A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A DEED OF DONATION WITH VARIOUS BENEFICIARIES FROM THE FIVE (5) BARANGAYS OF DISTRICT II, QUEZON CITY TO DONATE ONE HUNDRED SEVEN (107) UNITS OF MOBILE FOOD CARTS WITH BIKES AND TRANSFER THE OWNERSHIP THEREOF WITHOUT ANY COST TO THE RECIPIENTS

WHEREAS, in furtherance of the City's commitment to strengthen the Micro, Small and Medium Businesses, one hundred seven (107) units of Mobile Food Carts with Bikes were purchased through the funds of the Office of the City Mayor;

WHEREAS, the Mobile Food Carts with Bikes shall be distributed to qualified beneficiaries from Barangay Payatas, Barangay Commonwealth, Barangay Batasan Hills, Barangay Bagong Silangan and Barangay Holy Spirit;

WHEREAS, the following are the specifications of the Mobile Food Carts with Bikes to be donated and distributed:

- ROOF MADE OF TARPAULIN CANVAS (07-18 THICKNESS)
- BODY WALLING: GAUGE 18 STAINLESS
- BODY FRAME: ANGLE BARS ¼ INCH X 1 INCH
- SQUARE TUBE: 1 ¼ INCHES X 1.5 INCHES
- BIKE ROUND TUBE: ½ INCH X S40, ROUND BAR ¼ AND ¼
- TABLE TOP: STAINLESS SHEET (HAIRLINE) 1 X 0.5MM
- BIKE MADE OF G.I. HEAVY DUTY TYPE
- WHEEL SIZE: 20 ½ DIAMETER (3 PCS)
- WITH JUICE JAR HOLDER AND SAUCE HOLDER
- PAINTED WITH AUTOMOTIVE PAINT
- BODY WALLING: STAINLESS
- INCLUSIVE OF KEROSENE STOVE AND WOK PAN 14 INCHES DIAMETER;

WHEREAS, to effectively turnover the ownership of the said Mobile Food Carts with Bikes without cost to the recipients, a Deed of Donation shall be executed with all fees and other related expenses assumed by the City.
