A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A DEED OF DONATION WITH VARIOUS BENEFICIARIES FROM THE FIVE (5) BARANGAYS OF DISTRICT II, QUEZON CITY TO DONATE ONE HUNDRED (100) UNITS OF TENTS AND TRANSFER THE OWNERSHIP THEREOF WITHOUT ANY COST TO THE RECIPIENTS

WHEREAS, to ensure the residents' protection from harsh weather conditions, especially when there is a need for evacuation in the event of fire, flood, typhoon and other calamities or emergency cases, one hundred (100) units of tents were purchased through the funds of the Office of the City Mayor;

WHEREAS, the said tents may also be used for meetings and activities of different Homeowners' Associations in their respective barangays;

WHEREAS, the tents shall be distributed to qualified beneficiaries from Barangay Payatas, Barangay Commonwealth, Barangay Batasan Hills, Barangay Bagong Silangan and Barangay Holy Spirit;

- TENT 11FT. X 11FT. CUSTOM MADE
- TENT FRAME: GI PIPE POST & TRUSSES, GALVANIZED TUBE: 0.75 X 1.5" X S#20 FLAT BAR: 1.25" X 6MM THICK COATED WITH SILVER PAINT
- COLLAPSIBLE TENT COVER: 22 ONCE VINYL COVERS WITH FULL DIGITAL COLOR PAINT;

WHEREAS, to effectively turnover the ownership of the said tents without any cost to the recipients, a Deed of Donation shall be executed with all fees and other related expenses assumed by the City.
