A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE TO BE USED FOR THE COVERAGE OF PROJECTS AND PROGRAMS OF THE QUEZON CITY GOVERNMENT, CHARGEABLE AGAINST THE BUDGET FOR YEAR 2023 OF PUBLIC AFFAIRS AND INFORMATION SERVICES DEPARTMENT (PAISD)

*WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;*

*WHEREAS, in 1976, by virtue of Executive Order No. 21 issued by the former Mayor Norberto S. Amoranto, the Public Affairs and Assistance Office was created which later on evolved into what is presently known in Quezon City Hall as Public Affairs and Information Services Department (PAISD);*

WHEREAS, the PAISD is mandated to keep the constituents of Quezon City well informed about the City Government's plans and programs, to inspire their support for and participation in those plans and programs, and to assist in the information dissemination components of the City Government's programs and projects;

WHEREAS, the PAISD is the legally mandated information agency and lead media service unit of the local government of Quezon City;

WHEREAS, there is a need to purchase one (1) unit of motor vehicle to be used for covering the projects and programs of the Quezon City Government, with the following specifications:
