A RESOLUTION RENEWING THE SPECIAL PERMIT OF COOLGAMES.COM, INC., TO OPERATE AN ELECTRONIC GAMES (E-GAMES) ESTABLISHMENT AT 2ND FLOOR, VERDE ORO BUILDING, COMMONWEALTH AVENUE, BARANGAY MATANDANG BALARA, DISTRICT III, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

WHEREAS, Coolgames.Com, Inc., a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by III Yup Hwang and with principal address at the 4th Floor, 3BB Building, No. 79 Kamuning Road, Barangay Kamuning, District IV, Quezon City, is applying for a Special Permit to operate an Electronic Games (E-Games) establishment;

WHEREAS, the applicant was previously granted a Special Permit by the Quezon City Council for the operation of an E-Games establishment through Resolution No. SP-7645, S-2018;

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew its Special Permit pursuant to an existing City ordinance;

WHEREAS, the operation of an E-Games establishment is regulated and licensed by the Philippine Amusement and Gaming Corporation (PAGCOR);

WHEREAS, the aforementioned business activity will provide employment and additional revenue to the City Government;

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the City Council to grant or renew a Special Permit to business activities of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of Coolgames.Com, Inc., to operate an Electronic Games (E-Games) establishment at 2nd Floor, Verde Oro Building, Commonwealth Avenue, Barangay Matandang Balara, District III, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate an E-Games establishment granted herein shall be subject to the following conditions:


1. The holding of E-Games shall be in accordance with the rules and regulations promulgated by PAGCOR;
2. The operation of an E-Games establishment shall not include playing of games not related to or other than E-Games;
3. The operation is enjoined to prohibit from playing the abovementioned games in their gaming site individuals below twenty-one (21) years of age or students of any school, college or university;
4. Coolgames.Com, Inc., shall remit to the City Treasurer a license fee of three percent (3%) of the gross receipt of herein grantee, which shall be made payable yearly to the City Treasurer during the lifetime of this Resolution in accordance with Section 25 of Ordinance No. SP-2773, S-2018, as amended; and

5. *This Resolution is non-assignable, non-transferrable and site-address specific.*

RESOLVED FINALLY, that this renewal of a Special Permit to operate an Electronic Games (E-Games) establishment shall be valid for a period of two (2) years from the approval of this Resolution and may be renewed by the City Council.
