RESOLUTION NO. SP- **9327**, S-2023

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO THE ASCENSION PROPERTY MANAGEMENT CORPORATION FOR THE CONSTRUCTION AND OPERATION OF A WET AND DRY MARKET (AS BUILT) LOCATED AT LOT 30 B-2, BLOCK PSD-1156, N. RAMIREZ STREET, BARANGAY NOVALICHES PROPER, DISTRICT V, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016

WHEREAS, the Ascension Property Management Corporation is applying for the issuance of a Certificate of Exception for the construction and operation of a wet and dry market (As Built) located at Lot 30 B-2, Block Psd-1156, N. Ramirez Street, Barangay Novaliches Proper, District V, Quezon City;

WHEREAS, pursuant to Section 55, Article VIII of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, an exception is required for the aforementioned project only upon authorization by the Quezon City Council;

WHEREAS, the proposed project will not adversely affect public health, safety and welfare, and is in keeping with the general pattern of development in the community;

WHEREAS, the Sanggunian of Barangay Novaliches Proper, as well as the homeowners and residents thereat, did not interpose any objection to the proposed project;

WHEREAS, Ascension Property Management Corporation has complied with all the necessary and mandatory requirements relative to its application.


