A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO REDHEART COLUMBARY/DANILO M. DY, OWNER OF THE LOT COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 004-2015008552, FOR (AS BUILT) FIVE (5)-STOREY RED HEART COLUMBARIUM ONLY, LOCATED AT LOT 5, BLOCK 2, ROMA STREET CORNER LATINO ROAD, NEOPOLITAN BUSINESS PARK, BARANGAY GREATER LAGRO, DISTRICT V, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016

WHEREAS, Redheart Columbarium/Danilo M. Dy is applying for a Special Use Permit for (As Built) Five (5)-Storey Red Heart Columbarium only, located at Lot 5, Block 2, Roma Street corner Latino Road, Neopolitan Business Park, Barangay Greater Lagro, District V, Quezon City;

WHEREAS, pursuant to Section 55, Article VIII of Ordinance No. SP-2502, S-2016, an exception may be allowed only upon authorization from the City Council, through a resolution;

WHEREAS, the proposed project will not adversely affect public health, safety and welfare and is in keeping with the general pattern of development in the community;

WHEREAS, the proposed project shall support economic-based activities, shall provide livelihood, vital community services and facilities and at the same time, shall pose no adverse effect on the zone or community;

WHEREAS, the permit of the proposed project will not adversely affect the appropriate use of the adjoining property in the same district;

WHEREAS, the permit of the proposed project will not alter the essential character and general purpose of the district where the exception sought is located;

WHEREAS, the applicant has complied with all the mandatory requirements prescribed by law, ordinance and administrative issuances;

WHEREAS, the applicant has submitted all the necessary and mandatory requirements in support of the proposed project and undertakes to comply with the provisions of existing laws, ordinances, rules and regulations pertaining to public safety, environmental protection and vehicular traffic.
