A RESOLUTION AMENDING RESOLUTION NO. SP-9200, S-2023, ENTITLED "A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT REPRESENTED BY DSWD SECRETARY REXLON GATCHALIAN, FOR THE IMPLEMENTATION OF THE ASSISTANCE TO INDIVIDUALS IN CRISIS SITUATION (AICS) PROGRAM IN QUEZON CITY GENERAL HOSPITAL" TO INCLUDE NOVALICHES DISTRICT HOSPITAL AND ROSARIO MACLANG BAUTISTA GENERAL HOSPITAL

WHEREAS, on March 13, 2023, the Quezon City Council has adopted Resolution No. SP-9200, S-2023 granting authority to the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with the Department of Social Welfare and Development (DSWD), represented by DSWD Secretary REXLON GATCHALIAN, for the implementation of the Assistance to Individuals in Crisis Situation (AICS) Program in Quezon City General Hospital;

WHEREAS, Memorandum Circular No. 06, Series of 2023, signed by the Secretary of DSWD last March 29, 2023, provides for the Amendment to the Memorandum Circular No. 16 Series of 2022, entitled Revised Guidelines on the Assistance to Individuals in Crisis Situation, to ensure faster and more efficient delivery of assistance through the said program;

WHEREAS, the Program Management Bureau – Crisis Intervention Division (PMB-CID) of the DSWD Central Office is in charge of the nationwide implementation and monitoring of the AICS Program in coordination with the Field Offices;

WHEREAS, the financial assistance that may be provided to eligible beneficiaries may be for medical services at the lowest possible cost without sacrificing the quality of services;

WHEREAS, there is a need to amend the resolution to include Novaliches District Hospital and Rosario Maclang Bautista General Hospital for the implementation of the AICS Program;

WHEREAS, among the obligations of Quezon City hospitals are to open an Authorized Government Depository Bank Account, preferably with the Land Bank of the Philippines (LBP) or any Authorized Government Depository Bank Account, provided that all transaction charges incurred will be shouldered by the service provider; and to provide the DSWD Finance Management Services, Cash Division/Unit, through the Program Management Bureau – Crisis Intervention Division/Section, its Bank Account Details where settlement of accounts shall be credited;


WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to amend, as it does hereby amend, Resolution No. SP-9200, S-2023, entitled “A Resolution Authorizing the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with the Department of Social Welfare and Development, represented by DSWD Secretary Rexlon Gatchalian, for the implementation of the Assistance to Individuals in Crisis Situation (AICS) Program in Quezon City General Hospital”, to include Novaliches District Hospital and Rosario Maclang Bautista General Hospital.

RESOLVED FURTHER, that the Quezon City General Hospital, Novaliches District Hospital and Rosario Maclang Bautista General Hospital are hereby authorized to open separate bank accounts where settlement of accounts with DSWD shall be credited.
