A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, FOR AND ON BEHALF OF THE QUEZON CITY LOCAL GOVERNMENT, TO CONSENT FOR THE SALE AND TRANSFER OF THE TWELVE (12) IDENTIFIED PROPERTIES IN BARANGAY BAGUMBUHAY, DISTRICT III, QUEZON CITY FOR THE METRO MANILA SUBWAY PROJECT RIGHT-OF-WAY AND SITE ACQUISITION

WHEREAS, the Department of Transportation (DOTr) is developing the Metro Manila Subway Project (MMSP), the alignment of which requires the Republic of the Philippines to acquire a Right-of-Way (ROW) in accordance with the requirements under Republic Act No. 10752, also known as "Right-of-Way Act of 2016";

WHEREAS, the MMSP will traverse in portions of Barangay Pinyahan and Barangay Bagumbuhay to accommodate the East Avenue Station and Anonas Station;

WHEREAS, twelve (12) identified lots, to be utilized in the ROW acquisition in Barangay Bagumbuhay, were previously owned by the Quezon City Government as subject to the Direct Sale Program and were already transferred under the names of the beneficiaries;

WHEREAS, the affected lots are covered by Transfer of Certificate Title Nos. 004-2023001438, 004-2023001528, 004-2023001293, 004-2023001547, 004-2023001702, 004-2023001434, 004-2023001641, 004-20231202, 004-20233987, 004-20233563, 004-20234273 and 004-20233882;

WHEREAS, each of the said Titles contained an annotated restriction stating that "except by hereditary succession herein lot or any part thereof cannot be alienated, transferred or encumbered within ten (10) years from the issuance of the Transfer Certificate of Title without the written consent of the vendor";

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to amend, as it does hereby amend, the City Mayor, Honorable Ma. Josefina G. Belmonte, for and on behalf of the Quezon City Local Government, to consent for the sale and transfer of the twelve (12) identified properties in Barangay Bagumbuhay, District III, Quezon City, for the Metro Manila Subway Project Right-of-Way and Site Acquisition.
