CORPORATION TO PETRON CORPORATION

WHEREAS, Junction Jr. Corporation applied for, and was granted and issued, a Special Use Permit for the operation of (As Built) Petron Gasoline Refilling Station with Lube Service located at Lot 18, Block S-25 Tomas Morato Avenue Corner Timog Avenue, Barangay Laging Handa, District IV, Quezon City, through Resolution No. SP-8792, S-2021;

WHEREAS, the subject Petron Gasoline Refilling Station changed its operator as it was returned to its mother company, the Petron Corporation, which will manage and operate the said station;

WHEREAS, through Resolution No. SP-8792, S-2021, a Special Use Permit for the aforementioned Petron Gasoline Refilling Station was issued by the City Council to Junction Jr. Corporation;

WHEREAS, the said Gasoline Refilling Station will just change its operator from Junction Jr. Corporation to Petron Corporation and the same nature of business will be operated as to that applied for a Special Use Permit;

WHEREAS, the change of operator from Junction Jr. Corporation to Petron Corporation will amend the owner stated in Resolution No. SP-8792, S-2021, and the new operator submitted all the pertinent requirements in support of the amendment of the Special Use Permit and undertakes to comply with the provisions of existing laws, ordinances, rules and regulations pertaining to public safety, environmental protection and vehicular traffic.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to amend, as it does hereby amend, Resolution No. SP-8792, S-2021, changing the name of the owner in the issued Special Use Permit for the operation of (As Built) Petron Gasoline Refilling Station with Lube Service located at Lot 18, Block S-25, Tomas Morato Avenue corner Timog Avenue, Barangay Laging Handa, District IV, Quezon City, from Junction Jr. Corporation to Petron Corporation.
