WHEREAS, Pilipinas Shell Petroleum Corporation, a business entity duly registered under Philippine laws, is applying for a Special Use Permit to be used for the construction and operation of a gasoline refilling station (As Built) located at Lots 18, 20 and 22, Block 469, G. Araneta Avenue corner Maria Clara Street, Barangay Sto. Domingo (Matalahib), District I, Quezon City;

WHEREAS, in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, a Special Use Permit shall be required for the construction and operation of a gasoline refilling station, subject to the authorization by the City Council through a Resolution;
