A RESOLUTION RENEWING THE SPECIAL PERMIT OF NDM BINGO CENTER/HALL FOR THE OPERATION OF ELECTRONIC BINGO (E-BINGO) AT LOT 9, BLOCK 12, COMMONWEALTH AVENUE, BARANGAY COMMONWEALTH, DISTRICT II, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)

WHEREAS, NDM Bingo Center/Hall, a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by Mr. Perry Weinne Lato, and with business address at Lot 9, Blk 12 Commonwealth Avenue, Barangay Commonwealth, District II, Quezon City, Metro Manila, is applying for a Special Permit to operate an Electronic Bingo (E-Bingo) Games establishment;

WHEREAS, the applicant was previously granted a Special Permit by the Quezon City Council for the operation of the same business through Resolution No. SP-8338, S-2020;

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew its Special Permit pursuant to an existing city ordinance;

WHEREAS, Quezon City Ordinance No. SP-2773, S-2018, as amended, and Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorize the City Council to grant or renew a Special Permit to business activities of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of NDM Bingo Center/Hall for the operation of Electronic Bingo (E-Bingo) at Lot 9, Block 12, Commonwealth Avenue, Barangay Commonwealth, District II, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate an E-Bingo granted herein shall be subject to the following conditions:

- 1. The holding of E-Bingo Games shall be in accordance with the rules and regulations promulgated by PAGCOR;
- 2. The operation of E-Bingo shall not include playing of games not related to or other than E-Bingo Games;
- 3. The operation of E-Bingo is enjoined to prohibit from playing in the above-mentioned games in their gaming site individuals below twenty-one (21) years of age or students of any school, college or university;
- 4. NDM Bingo Center/Hall shall remit to the City Treasurer a license fee of three percent (3%) of the gross receipt of herein grantee, which shall be made payable yearly to the City Treasurer's Office during the lifetime of this Resolution in accordance with Section 25 of Ordinance No. SP-2779, S-2018, as amended; and
- 5. This Resolution is non-assignable, non-transferrable and site-address specific.

RESOLVED FINALLY, that this renewal of a Special Permit to operate E-Bingo shall be valid for a period of two (2) years from the approval of this Resolution and may be renewed again by the City Council.
