ESCAÑO-ARIAS, OFFICER-IN-CHARGE, QUEZON CITY HEALTH DEPARTMENT

WHEREAS, the entire Quezon City Government mourns with the family of the late Dra. Esperanza Anita N. Escaño-Arias, Officer-in-Charge, Quezon City Health Department, who passed away last September 3, 2023;

WHEREAS, the late Dra. Escaño-Arias successfully completed and passed the Physician's Licensure Examination in August 1987;

WHEREAS, Dra. Escaño-Arias started working as a Staff Physical Therapist at the State University of New York, Health Sciences Center, Brooklyn, New York in 1988 and a Senior Physical Therapist at the Metropolitan Jewish Geriatric Center, Brooklyn New York from 1988 to 1990. She became a Resident Physician for Pediatrics at the Armed Forces of the Philippines Medical Center from 1990 to 1994;

WHEREAS, Dra. Escaño-Arias has joined the Quezon City Health Department in 1994 as Medical Officer III and was designated as Officer-in-Charge of the Quezon City Health Department pursuant to Office Order No. 15, Series of 2019 dated July 5, 2019, issued by the City Mayor, Honorable Ma. Josefina G. Belmonte;

WHEREAS, Dra. Escaño-Arias was among the awardees during the 18th Gawad Parangal for her active service as one of the City's incident commanders. She also formulated the guidelines on testing, barangay contact tracing, among others, and led the direct coordination with Government and Non-Government Organizations for additional resources of the City. She was also a recipient of the 2021 Tandang Sora Award to recognize her contributions and services to ensure the safety of the City and its constituency during the COVID-19 pandemic;
