WHEREAS, Rephil Edsa Pasay Inc., a duly registered business entity under Philippine laws and through its manager Ms. Catherine A. Abela, is applying for the issuance of a Special Use Permit for the construction and operation of a gasoline station located at Lot 2, Block 177, Commonwealth Avenue corner Labayani Street, Barangay North Fairview, District V, Quezon City;

WHEREAS, the said proposed construction and operation is permissible to the zone classification. However, gasoline refilling stations are among those which require a Special Use Permit upon authority from the Quezon City Council, as provided in Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;
