A RESOLUTION RENEWING SPECIAL PERMIT OF PAYLINE THEINCORPORATED TO OPERATE AN ELECTRONIC BINGO (E-BINGO) ESTABLISHMENT AT UGF-111, Z SQUARE MALL, BANAWE STREET CORNER DEL MONTE AVENUE, BARANGAY MANRESA, DISTRICT I, QUEZON CITY, **SUBJECT** TOTHE **RULES** ANDREGULATIONS PROMULGATED BYTHE PHILIPPINE **AMUSEMENT** AND GAMING CORPORATION (PAGCOR)

WHEREAS, Payline Incorporated, a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by Mr. Justin Gotianse, with principal business and office address at AG003 Ground Floor, Saint Francis Square, Julia Vargas, City of Mandaluyong, is applying for a Special Permit to operate an Electronic Bingo (E-Bingo) establishment at UGF-111, Z Square Mall, Banawe Street corner Del Monte Avenue, Barangay Manresa, District I, Quezon City;

WHEREAS, on November 23, 2020, the City Council passed Resolution No. SP-8369, S-2020 granting a Special Permit to Payline Incorporated to operate an E-Bingo establishment;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to existing city ordinances, authorizes the City Council to grant or renew a special permit to a business activity of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of Payline Incorporated to operate an Electronic Bingo (E-Bingo) establishment at UGF-111, Z Square Mall, Banawe Street corner Del Monte Avenue, Barangay Manresa, District I, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate an E-Bingo establishment granted herein shall be subject to the following conditions:

- a) The holding of E-Bingo shall be in accordance with the rules and regulations promulgated by PAGCOR;
- b) The operation of E-Bingo establishment shall not include the playing of games not related to or other than E-Bingo;
- c) The operator is enjoined to prohibit individuals below eighteen (18) years of age from playing the abovementioned games.

RESOLVED FURTHERMORE, that Payline Incorporated shall remit to the City Treasurer's Office a franchise fee of three percent (3%) of the gross revenue of herein grantee which shall be made payable yearly to the City Treasurer's Office during the lifetime of this Resolution.
