Domingo, District I, Quezon City, are the true and lawful owners of a parcel of land delineated as one (1) road lot, consisting of sixty-nine (69) square meters and covered by Transfer Certificate of Title No. 004-2022009104:

WHEREAS, except by way of donation to the National or Local Government, the lot herein delineated as (existing road) shall not be closed or disposed of without approval of the court pursuant to Presidential Decree (PD) No. 1529;

WHEREAS, in compliance with the provisions of PD No. 1529, PD No. 957 and PD No. 1216, Spouses Lui hereby donate and convey to the Quezon City Government the subject road lot under their lawful ownership;

WHEREAS, a Deed of Donation for the transfer of ownership of the subject property will be signed and accepted by City Mayor, Honorable Ma. Josefina G. Belmonte, in behalf of the Quezon City Government, as Donee, and Spouses Michael Gan Lui and Christine Margaret C. Lui, duly represented by their Attorney-in-Fact, Maria Ramonette A. Rabanillo, as Donors;

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor, as Chief Executive of the City Government, shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to sign and accept the Deed of Donation and Acceptance in behalf of the Quezon City Government, as Donee, and Spouses Michael Gan Lui and Christine Margaret C. Lui, duly represented by their Attorney-in-Fact, Maria Ramonette A. Rabanillo, as Donors, for a parcel of lot delineated as road consisting of sixty-nine (69) square meters, located at Barangay Baesa, District VI, Quezon City and covered by Transfer Certificate of Title No. 004-2022009104.
