A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF TRADE AND INDUSTRY – NATIONAL CAPITAL REGIONAL OFFICE (DTI–NCRO) TO PROVIDE A SPACE FOR THE ESTABLISHMENT OF A NEGOSYO CENTER IN QUEZON CITY

WHEREAS, the Department of Trade and Industry – National Capital Regional Office (DTI – NCRO) is the primary agency tasked with the promotion and development of Micro, Small and Medium Enterprises (MSMEs) through the provision of various assistance and interventions such as financing, marketing and promotion, human resource development, product development, and advocacy, among others;

WHEREAS, Republic Act No. 9501 recognizes that MSMEs have the potential for more employment generation and economic growth and therefore can help provide a self-sufficient industrial foundation for the country. It is hereby declared the policy of the State to promote, support, strengthen and encourage the growth and development of MSMEs in all productive sectors of the economy;

WHEREAS, the Quezon City Government recognizes the value of MSMEs and their contribution to the local economy. Pursuant thereto, this City recognizes the specific needs of MSMEs and undertakes to promote entrepreneurship, support entrepreneurs, encourage the establishments of MSMEs and ensure their continuing viability and growth and thereby attain countryside industrialization through promotion of the same by strengthening development and assistance programs to micro, small and medium scale enterprises;

WHEREAS, DTI – NCRO is willing to enter into a memorandum of agreement with Quezon City Government in the furtherance of the establishment of a Negosyo Center which aims to promote ease of doing business, and facilitating access to services for MSMEs pursuant to Republic Act No. 10644, otherwise known as the "Go Negosyo Act", subject to the terms and conditions herein;

WHEREAS, DTI – NCRO has authorized its OIC-Regional Director Ma. Sofia G. Narag, to enter into an Agreement with the Quezon City Government;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor, as the Chief Executive of the City Government, shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to a law or ordinance.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with the Department of Trade and Industry – National Capital Regional Office (DTI–NCRO) to provide a space for the establishment of a Negosyo Center in Quezon City.
