WHEREAS, petitioner Rephil Dealers Inc., a duly registered business entity under Philippine laws, through its Manager, Ms. Catherine A. Abela, is applying for the issuance of a Special Use Permit for the construction and operation of a gasoline station to be located at Lot 1, Block 1, Belfast Avenue corner Roma Street, Neopolitan Business Park, Barangay Greater Lagro, Novaliches, District V, Quezon City;

WHEREAS, the proposed construction and operation is permissible to the zone classification. However, gasoline refilling stations are among those which require a Special Use Permit upon authority from the Quezon City Council, as provided in Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;
