WHEREAS, the Quezon City Government and the Hyundai Motor Philippines, Inc. (HMPH), recognize that a private-public partnership is essential in pursuing corporate sustainability, especially in the area of education;

WHEREAS, HMPH aims to provide education to work opportunities program for qualified underprivileged individuals under its "Hyundai Accelerate Program";

WHEREAS, HMPH will sponsor fifteen (15) qualified Quezon City residents for a one (1)-year Automotive Technology Vocational Program for SY 2023-2024 with Don Bosco Technical Institute of Makati;

WHEREAS, the primary role of the Quezon City Government under the partnership is to endorse qualified Quezon City residents and assist the beneficiaries in terms of allowances and obtaining necessary documents for the Program;

WHEREAS, both parties endeavor to support and promote each other's policies and programs pursuant to the objectives set out in the Memorandum of Agreement;

WHEREAS, pursuant to Section 455(b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with the Hyundai Motors Philippines, Inc. (HMPH) on the provision of education and work opportunities to fifteen (15) qualified residents of Quezon City under the "Hyundai Accelerate Program".
